Mitsubishi Chemical Composites America, Inc. (MCCA) hereby warrants to Customer that the metal composite panels of **Thickness - Color** to be supplied by MCCA to Customer pursuant to order placed by Customer and accepted by MCCA are, at the time of shipment, free from defects which would cause the said panels to delaminate to the extent that unevenness of the surface of said panels is visually recognizable by a normal person

This warranty is subject to the following conditions:

- A. This warranty will not be applicable to defects of any other sorts or distortion occurring after shipment caused by any reasons including, without limitation, corrosive or aggressive atmospheres, depreciation, wear and tear, defective subsidiary materials furnished or workmanship performed by others, including installation workmanship, defects in the building structure, or other forces, conditions or circumstances unrelated to the quality of ACM at the relevant date of shipment, or failure of building owners or occupants to do normal maintenance
- B. This warranty will be applicable for ACMs which are a rout and return tray panel, an exposed cut edge panel, and/or a perforated panel which has 45% of perforation ratio at the maximum to the non-perforated panel;
- C. This warranty will be applicable for ACM with 0.5mm thick aluminum skin both sides and gray fire-retardant core or black PE core, in the case of an exposed cut edge panel and/or a perforated panel;

- D. This warranty will not extend to or cover damage to ACM caused by handling, shipping, processing and/or installation, or damage to ACM caused by scratching or abrading after installation;
- E. This warranty will not be applicable for the project where located within from 1 mile or 1.6 km of a body of salt water with regard to an exposed cut edge panel, or a perforated panel application.
- F. This warranty will not be applicable to any damage or failure that is caused by act of God, falling objects, external forces, explosions, fire, riots, civil commotion, war, radiation, or other similar or dissimilar occurrences beyond MCCA's control; and MCCA agrees to repair or replace, at its sole cost and discretion, any metal composite panels of such defects as shall have been proven by customer to the satisfaction of MCCA not to be in compliance with the aforesaid warranty. The above obligation of MCCA is expressly conditioned upon (i) receipt by MCCA of notification in writing from Customer of any claimed non-compliance with the warranty pursuant to this letter within **thirty (30) days** after such non-compliance first comes to the attention of Customer and within ten years after the date of each shipment; (ii) full compliance by Customer with instructions given by MCCA whether in written or oral form, and normal practices of the design, construction and real property industries and of the industry to which Customer belongs with respect to handling, delivering, storing, processing, treating, installing and maintaining such metal and composite panels ("Instruction and Practice"); and (iii) provision by Customer to its employees, contractors and customers with relevant parts of Instruction and Practice.

Customer's failure to satisfy any of the above three conditions shall be construed as the waiver by Customer of any right it may have to enforce this warranty.

No warranty, expressed or implied, other than specifically set forth above is given or is to be implied with respect to any material furnished by MCCA and MCCA expressly disclaims all other expressed and implied warranties, including warranties of merchantability and fitness for a particular purpose. The original purchaser understands, agrees and accepts this warranty. Warranty becomes effective only when signed by a duly authorized agent of Mitsubishi Chemical Composites America, Inc. and issued.

THIS WARRANTY AND REMEDY IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WRITTEN OR ORAL, EXPRESSED OR IMPLIED AND INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL MCCA BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL LOSSES OR DAMAGES (INCLUDING, BUT NOT LIMITED TO, ECONOMIC LOSS OR LOSS OF PROFITS) SUFFERED OR INCURRED BY CUSTOMER AS A RESULT OF OR IN CONNECTION WITH ANY REACH OF THIS WARRANTY BY MCCA EXCEPT IN THE CASE OF GROSS NEGLIGENCE OR WILLFULNESS OF MCCA.
